

# Rules of Procedure of EURO CC 2010.

1. Entry forms are processed in the order of arrival. For reasons of organization we limit visits to 900 teams. Dinner optional. Extension limited to 200 teams with the criterion of choice and removal date.

2. Members of the FFACCC must register individually, payment by personal bank checks to CCCEst, these checks will be processed end of February 2010.

For other European countries registrations go through the clubs.

Payment by global bank transfer to the following account:

**Registration deadline: February 20, 2010**

3. Any incomplete registration form, or not accompanied by full payment, or received after the deadline will not be taken into account.

4. Withdrawal rule:

- Until 2010-02-19: deduction of € 10 per crew.
- From 2010-02-20 to 2010-05-15: deduction of € 30 per crew.
- From 2010-05-16: deduction of € 50 per crew.

The clubs will be able to replace one crew by another (same registration, meals and extension conditions) after having informed the organizers.

5. Any expulsion, decided by the Organizing Committee (improper behaviour, stray dog etc.) will not result in any refund.

6. The crews will arrive on site on 20 May between 9am and 7pm. They will be grouped in blocks of 25 crews, grouped by clubs where possible.

7. Participants who do not show on time at the appointment for a planned visit by negligence, omission or delay will have no opportunity to catch up.

8. No electrical connection provided. For safety, it is forbidden to light fires (barbecue), play ball, to move the vehicle and to perform any action that could be dangerous for participants. If necessary, refer to the organizing committee.

9. Dogs must be leashed and brought to the places reserved. The "accidental droppings" must be collected in bags and put in the trash. Dogs are prohibited in buildings and means of collective transportation (Train, Bus). Violators will be called to order and expelled if needed.

10. The organization accepts no liability for theft, damage or injury of any kind that may occur on the site or during the extensions.

11. An envelope will be sent to each participating team to the address on the registration form. It will include all information necessary for arriving at the site and a cardboard with instructions for reaching the assigned parking area. This board will always be visibly posted on the windshield of the vehicle before the arrival. Each driver must comply with the guidelines of the Agents.
